Road Report:

Change oils and filters in the 2014 and grease

Took 19' to Bradco for heated wipers and plow frame repair

All Bills on hand were paid.

The board reviewed and signed the annual CDL paperwork.

An inspection on the F550 revealed far too many repairs to be done for the township to move forward on getting the F550 road ready and usable. Selling the truck and or parts was discussed but this matter is tabled until next month.

Aggregate Bids were opened from Stagecoach, Dalrymple, H & K Group, Lopke, and Johnson's Quarries. Milt made a motion to accept Dalrymple's ASHHTO #8 washed stone for seal coat at \$26.00 a ton, delivered and Lopke #8 unwashed stone for \$19.00, delivered. Chad Cooley seconded this motion and the motion passed.

Milt Robinson made a motion to advertise for Seal Coat equipment rental. John Strope seconded this motion, Chad Cooley made it unanimous, and the motion passed.

Chad Cooley made a motion to advertise for EDP oil and AEP oil. John Strope seconded this motion, Milt Robinson made it unanimous, and the motion passed.

Milt made a motion to advertise for the May 8th Township Spring Cleanup. Chad seconded this motion, John made it unanimous, and the motion passed.

It was decided to submit Hall Rd., Potterville St., and Dehaan Rd. into the dirt and gravel road program.

Milt confirmed that Jeff Robbins is on the ballot to run for supervisor.
