Dust oil bids were opened from Midland Asphalt Materials Inc. and Suit-Kote Corporation. Chad Cooley made a motion to accept Suit-Kote Corporation's bid for 20,000 +or- of AEP or EDP at \$2.14 a gallon. John Strope seconded this motion and the motion passed.

The minutes of the last monthly meeting were read. John Strope made a motion to accept the minutes as written. Chad Cooley seconded the motion and the minutes of the last monthly meeting were approved as written. The Treasurer's Report was reviewed. Chad Cooley made a motion to accept it as written, John Strope seconded it, and the treasurer's report was approved as written.

Had Mountain Lake Construction come fix cable on garage door.

JBK Logging, John Kolesar cut the right of way back on Bonin Rd. for the Dirt and Gravel Rd. Project

Held the Spring Clean Up at the bldg. on April 1st.

All Bills on hand were paid.

No word back from Matt Dewing after Chad informed him of our plans moving forward regarding tar and chipping Lovett Hill Road. This matter is considered complete.

John Strope made a motion to advertise for extra dust oil available for purchase to township residents. Jeff Robbins seconded that motion and the motion passed.

Chad Cooley made a motion to have John Strope submit applications into the Dirt and Gravel Road Project program for the other half of Bonin Road and Dehaan Road to be considered for 2024. Jeff Robbins seconded that motion and the motion passed.
