

**ROAD NAME ORDINANCE
OF ORWELL TOWNSHIP, BRADFORD COUNTY, PA
ORDINANCE NO. 2010-1**

IT IS HEREBY ORDAINED AND ENACTED by the Supervisors of Orwell Township, Bradford County, Pennsylvania:

SECTION I - AUTHORITY

This ordinance is enacted pursuant to 53 PS. 66506, General Powers, Health & Welfare and 53 PS. 66527 - Secure Public Safety.

SECTION II - PURPOSE

It is the purpose of this ordinance to promote the public health, safety, welfare by effectively placing road names into record. In so doing, the municipality is preparing itself and its citizens for the eventual re-addressing phase of the Bradford County 9-1-1 Enhancement Project.

SECTION III - DEFINITIONS

Road - Includes any public street, road, lane, court, cul-de-sac, public way, and Public Square, as well as certain private driveways, which are now or shall hereafter become subject to the authority of the Board of Supervisors to name streets.

SECTION IV - ROAD NAMING

- (A) Accompanying the Ordinance and the attached list of road names is a map depicting the Township roads. The map, attached hereto is incorporated hereto by reference, (APPENDIX A).

For future reference, a full sized copy of the map shall be recorded simultaneously with this Ordinance in the Bradford County Register and Records Office.

- (B) Attached to this Ordinance and incorporated herein by reference, (APPENDIX B) is a list of all the municipal and private road names.

- (C) The effect of the of the official Township road map incorporated into and made part of this ordinance shall be to indicate the names and locations of all the Township roads. Any road not included on the said map shall not be deemed to have been vacated by the Board of Supervisors, nor shall the road or road lines indicated thereon be deemed to constitute the opening or establishment of any road, nor the taking or the acceptance of any land for street purposes, nor shall it obligate the Township to improve or maintain any such road. The map shall be in no way conclusive as to the exact and precise location of any road or landmark hereon.

(D) Petition to Change the Name of an Existing Street: Upon written petition of at least $\frac{2}{3}$ of the persons owning surface rights to property abutting an existing street, the Board of Supervisors may change the name of an existing street, provided that:

- (1) The proposed new name shall not duplicate the name of any existing road, as specified in Section 2, E. of the Bradford County Street Naming and Addressing Policy.
- (2) In those instances where a road is located in more than one municipality, the petitioners shall obtain the approval of all municipalities within which the street is located.

SECTION V - PUBLIC REVIEW AND COMMENT

With the adoption of this Ordinance, the public has been allotted its opportunity for comment as prescribed by 53 PS. 66601 - Ordinances, and 65 PA. C.S. 701-716 (The Sunshine Act).

SECTION VI - SEVERABILITY

If any portion of this Ordinance and any Amendments made hereto are held unconstitutional or invalid by a court of competent jurisdiction, the remainder of this Ordinance and Amendments made hereto shall not be affected and shall remain in full force and effect. If any statute referred to in this Ordinance shall be amended, this Ordinance shall be deemed to refer to such statute amended.

SECTION VII - ENACTMENT

With the following signatures the Board of Supervisors of the Township of Orwell agree that the map accurately describes the names of municipal roads in their Township from this date forward.
